8.- Maintaining the sensitisation and awareness of all our employees, encouraging their environmental training, promoting their active participation with the aim of supporting continuous improvement.

9.- To support the acquisition of energy-efficient products and services, as well as design activities that have an impact on and take into account improved energy performance.

Likewise, the organisation undertakes to implement and maintain Chain of Custody requirements, according to PEFC/FSC reference standards and social requirements regarding workplace health and safety, based on applicable legislation and the "1998 ILO Declaration on Fundamental Principles and Rights at Work".

MGT does not cooperate under any circumstances with any organization involved in illegal forestry products, the violation of human rights, the destruction or use of non-forestry woodlands or the violation of any of the Fundamental Agreements of the OIT.

MGT is committed to complying with basic labor requirements, such as:

- In no case shall child labor be used.
- Forced or coerced labor is prohibited.
- There shall be no discrimination in employment and occupation.
- Freedom of association and the effective right to collective bargaining shall be respected.
- In no case shall genetically modified organisms be used in forestry operations for purposes other than research.
